Dr. Seniuk noted all three schools are holding their Science Fairs and that a lab coat can really make you want to be a scientist! She was happy to see children playing on the new Old Mill Road Playground, which has been completed, and was fully funded by a legislative grant. Dr. Seniuk is working to procure more grant money to cover playgrounds for all three schools. Lastly, she announced that the first annual Mindfulness Retreat for students in grades 4 through 6, sponsored by the North Merrick Mental Health and Wellness Coalition, was held on April 1, and included workshops on yoga, Zumba, breathing, and meditation.

Resident Maeve Schultz spoke about the Universal Pre-Kindergarten(UPK) program and expressed her frustration with the lengthy process and not knowing the locations. She suggested finding additional locations and funding for this program, and she stated that parents should have more of a choice for placement like neighboring districts allow.

Ms. Ryan commented that Superintendent Dr. Seniuk would speak about UPK, and said the district is actively looking to add more seats.

Dr. Seniuk stated that North Merrick brought in UPK last year and was able to get a seat for every student that was requested. She explained about state funding and the tuition rate for preschool and said the district is working to allocate 114 seats. Dr. Seniuk said she was going to a site tomorrow for a tour, and pending approval from the state, to bring SCOPE in to run the program there. She stated that there are school districts in Nassau County that received substantial money for UPK but are unable to provide it for their communities because they are unable to find preschools to participate. Dr. Seniuk said some districts use SCOPE in-house, but North Merrick does not have enough classroom space.

Resident Robert Rolling asked whether the district should wait until after the budget vote before drawing the lottery for UPK placement. But Dr. Seniuk stated that UPK does not impact the budget because the funding comes directly from the state.
