Ms. Ryan spoke about the school reopening task force, and the participation of parents, teachers and administrators. She thanked them all for their work behind the scenes to put a plan in place for the upcoming school year. She said that district administrators and WINGS students visited Nassau University Medical Center to present 400 masks extenders (which the students printed on the district's 3D printers) as well as inspirational videos they created on QR codes attached to the mask extenders. Ms. Ryan said the doctors and the nurses were so appreciative, and all 400 of the mask extenders were distributed by 2 p.m. that afternoon. In addition, Ms. Ryan stated that the district was served with a notice of petition on the previous Friday, and district counsel Neil Block is handling it appropriately. She went on to thank the Friends for Good Health for donating four temperature screening machines to the district. This system will take contactless temperature readings of all staff, students and visitors upon entry and will also notify when a mask is not being used along with other safety features.

3. SUPERINTENDENT'S COMMENTS

Information: A. Comments

Superintendent of Schools, Dr. Cynthia Seniuk, stated that the district's school reopening task force committees have been diligently working over the last few weeks and reporting back to the larger task force. She thanked the parents, administrators, board members, and staff who have been participating in this important work. Moving forward, she said the task force is looking to put together several plans that would be fluid, meaning that however the schools reopen in September, the district will be prepared to move from plan A to plan B at a moment's notice. Dr. Seniuk noted that surveys were sent out this evening to parents and instructional and non-instructional staff for their input. She said she appreciates this feedback and will use the suggestions in planning and decision-making. The surveys are due back on July 8th by 5 p.m. Dr. Seniuk stressed how important it is for the lines of communication to be kept open. She said the district is gathering information, listening to concerns, and trying to address them to the best of our ability. She said North Merrick is working closely with the component districts as well as all districts across Nassau County. The districts need to report to the New York State Education Department and follow the mandates of the Department of Health as well as the Centers for Disease Control (CDC) guidelines. Dr. Seniuk stated that the process is a balancing act, but everyone is working diligently to ensure that school districts open in a safe manner. She then mentioned that the summer packets for student enrichment were distributed this week from each of the school buildings. She asked that if parents were unable to pick up the packets to please email their principal to make alternate accommodations. Dr. Seniuk noted that the summer programs for the Extended Year Program and remedial reading are kicking off next week. Lastly, she encouraged everyone to view the summer packet for enrichment activities, which is posted on the district website homepage.
