Sam Carder, Director of School Facilities, stated there have been many celebratory ceremonies for students and there were many happy parents, and it took a lot of coordinating for the set-ups and break-downs of chairs and equipment. He thanked the custodians and maintenance crew for all their efforts in making everything go smoothly. He said that was in addition to all the preparations for the budget and board vote. Mr. Carder gave kudos to Mrs. Long for the work she put into it. He stated that the district is now preparing for the Extended School Year summer program, which was a last-minute state mandate, so they were trying their best to get that going. Mr. Carder stressed that the district wants to assure everyone attending in person to feel safe and well-protected. He is also working closely with the School Reopening Task Force, whose members have had great ideas and are lending both their time and expertise, but he noted that districts are still awaiting direction from the Governor. Mr. Carder spoke about projects that were voted on in May of last year that the district now has permits to start. He said he is reconfirming pricing and will get the projects on schedule to be completed during the summer. He added there have been a lot of painting projects, including the bottom of the Camp Avenue School building that has been painted white. Custodial staff is returning next Wednesday, and for their protection and safety, he said the district must be ready with work protocols, so there has been a lot of discussion regarding that.

In addition, Mr. Carder said that IT administrator Wing Lau is working with a donation of 14 used SmartBoards, which will be utilized for parts to ensure the working SmartBoards can be repaired and back up and running. This project to support the district's technology infrastructure is also scheduled to happen this summer.

Mr. Carder thanked Jon Simpkins in the high school district and Mr. DeTommaso in helping North Merrick with security to patrol our grounds on weekends when youngsters with nothing to do end up congregating on district property.
