2. SUPERINTENDENT'S COMMENTS

Procedural: B. Presentation - Celebration of Retirees

Ms. Ryan noted that the Board of Education Reorganization meeting will be held on July 6, with the executive session starting at 3:00 PM and the public meeting at 4:00 PM. She noted that the high school reorganization meeting will be held the week after. Dr. Seniuk then introduced retiring staff. She first introduced Corinne Armstrong, who began her career in North Merrick as a substitute teacher in 1991. She said Mrs. Armstrong has taught kindergarten and second, third and fourth grade in the district. Laura DeLuca, Old Mill Road Principal, added that Mrs. Armstrong has worked in the district for 30 years, and she has been honored to work with her at Old Mill Road School for 17 of those years. Ms. Deluca stated that Mrs. Armstrong has always been her go-to person since starting her role as principal at Old Mill. She said that when entering Mrs. Armstrong's classroom, no matter what day, no matter what time, there is learning going on, along with students having fun. Ms. DeLuca wished Mrs. Armstrong a wonderful retirement and thanked her for her dedication to the students at Old Mill Road.

Next, Dr. Seniuk introduced Nancy Pantaleo, who started at Old Mill Road School in 1991 as a second grade teacher, and has since taught first, third, fourth, and sixth grade at Old Mill Road. Mrs. DeLuca stated Ms. Pantaleo has been with the district for 30 years and is a most dedicated teacher, who has a calm demeanor no matter what was happening in the classroom. She added that Ms. Pantaleo goes with the flow and the students love and adore her. She said Ms. Pantaleo introduced her students to morning meetings before it was a district initiative and wished her all the best in retirement.

Dr. Seniuk then introduced Melissa Portmore, who started as a substitute teacher and then taught first grade for eleven years at H.D. Fayette School. H.D. Fayette Principal, Howard Merims said Mrs. Portmore gave her heart and soul to Fayette. He said that when you walked into her classroom, you could feel that special warmth for her students, and the faculty, staff and parents loved, respected and trusted her. He wished her all the best in this new chapter and spending more time with her loving children and new granddaughter. Mr. Lentini also thanked Mrs. Portmore for being there for his child through this very difficult year.

Discussion, Information, Procedural: B. Comments

Mr. Smith, North Merrick Library President, asked about the status of LIPA PILOT funding. Ms. Ryan stated the resolution would be added to tonight's meeting regarding the settlement, and Mr. Smith thanked the board.

Resident Kimberly Stahl stated that the district should not implement Critical Race or tell students to evaluate their inherent bias. Ms. Stahl also stated that it is time to unmask students and feels the district is failing children by not taking action, as the Massapequa and Farmingdale School Districts have done. She said North Merrick has the right to stand against the mask mandate. Ms. Ryan, Board President, replied that she is very proud of what the district has done over the past year and half and said Ms. Stahl should contact the state legislature and governor's office. She stated the district is not failing children, and that students are thriving. Ms. Ryan said North Merrick is a great district, which has kept the schools open all year and did not cut teachers or programs.

Resident Chad Laveglia agreed that North Merrick is a great district but questioned what could be done about the mask mandate for students. Mr. Block, district counsel, stated that the district is required to follow the Govenor's Executive Order, and the superintendent takes an oath of office to obey the law. Mr. Laveglia said he hoped the district can do something so that students will not be required to wear a mask in September. Mr. Block replied that the state seems to be trending in that direction and hopefully there will not be a mask mandate in September.

Mr. Laveglia then asked about air conditioning in the schools, and Mr. Block said there are exemptions for students with medical issues or 504 plans, but on a case-by-case basis.

Resident Chris Mitkish expressed her gratitude to the board and central administration for all they have done for the students over the past year and noted that North Merrick and all the component districts have been a model for other districts on Long Island. She said she does not want to wear a mask any longer but respects the law. She noted that once the state reaches a 70-percent vaccination rate, that order may change, and we are almost there. Ms. Mitkish added that the district is teaching respect and kindness, not blaming students for historical events, and the district should be treated with respect and dignity. Ms. Ryan said the district must comply with all state mandates in order not to put the district in peril.

Resident Anna Higgins asked the the board to elaborate on agenda items 5E, F, N, and T before they voted, and she also questioned what the settlement agreement is regarding in Item T. Mrs. Ryan stated that the Assistant Superintendent for Business, Thomas McDaid, would speak to it before the vote.

Resident Mary Keene thanked Mr. Lentini and Ms. Gordon for serving on the board and asked for an explanation on agenda item 5E and when the district will receive federal funding. Ms. Ryan she would explain those items before the vote.

Mr. McDaid explained that there was an \$850,000 increase in the budget for COVID-related expenses, including additional staffing. The district utilized the "rainy-day fund" that he often mentions from the Fund Balance. Mr. McDaid said he submitted an application with the state to be reimbursed for these expenses and he hopes it will be fully reimbursed, but it's in the state's hands.

Dr. Seniuk added that the due date for the application was June 15, but the district felt it was best to get the application in as early as possible, expecting it could be on a first-come, first-served basis.

Mr. McDaid next discussed the \$150,000 grant the district was thankful to receive from the Town of Hempstead to help cover additional expenses for keeping the schools clean and functioning throughout the school year. Dr. Seniuk further explained that this was unanticipated revenue, and that is why the budget was revised to reflect this. Mr. McDaid also mentioned that there were additional hourly employees in the district and additional costs for tech aides, monitors, clerks, and summer help. In addition, Mr. McDaid noted that Item T was for a settlement of \$700 for We Transport, one of the bus companies the district hires to transport students, during the school closure.
