resignation for purposes of retirement (such letters to be submitted no later than 3:30 pm on April 1, 2019) by a minimum of at least two (2) full-time members of the teaching staff, upon the prior ratification and execution of an agreement with the North Merrick Faculty Association, the Board of Education authorizes the President of the Board of Education or the Superintendent of Schools to enter into, execute and deliver the agreement between the District and the North Merrick Faculty Association with respect to a retirement incentive in accordance with the terms and provisions of such agreement, as detailed in the mailing.

Dr. Seniuk stated the legal notice had a typo which needed to be corrected. She explained that the teacher retirement incentive for the NMFA will be financially beneficial to the district.
